Spring Cleanup Information

Spring Cleanup is scheduled for April 19th thru April 22nd

All items must be dropped off at the City Garage, 1101 Main St.

- Wednesday, April 19th thru April 21st 7:00a.m. to 7:00p.m.
- Saturday, April 22nd 7:00a.m. to 1:00p.m.

This collection program is for **City Residents only! No commercial/industrial** items will be accepted.

Items that will be accepted at no charge include: Computer printers, computer processing units (keyboards-CPU's-monitors), couches, chairs, beds, windows, boards, carpeting, building materials, water heaters, microwaves, washers, dryers, dishwashers, bicycles and rimless tires. Call the number below if you are unsure about an item.

The following items will also be accepted on Saturday – (These items will also be accepted Wednesday thru Friday if paid in advance at City Hall)

For each of the following items dropped off, you will be charged \$15: Refrigerators, welders, humidifiers, and dehumidifiers, freezers, air conditioners, television sets, water coolers, ice machines, VCR, DVR and L.P. tanks.

<u>Tire disposal.</u> Residents will need to stop at City Hall and obtain a voucher for tire disposal. Voucher must be presented at the collection site before any tires will be accepted. <u>A limit of 4 tires per address will be allowed.</u>

For the disposal of fluorescent light bulbs, we will be charging \$2 per bulb.

Items that will not be accepted include: Leaves, brush, yard waste, newspapers, plastics, hazardous materials, paint, household garbage and recyclables.

OPEN BOOK AND BOARD OF REVIEW SCHEDULED

Open Book – May 4th 1pm to 3pm

Board of Review – May 23rd 3pm to 5pm

Telephone Open Book Appointments will be available Thursday May 4th from 1:00 PM to 3:00 PM

You do not have to attend the Open Book to speak with an assessor, you may contact Accurate any time prior to the Board of Review. To set up an appointment log on to <u>www.accurateassessor.com</u> click the online **APPOINTMENTS** link on top of the screen. If you do not have Internet access, please call **1-800-770-3927** to schedule an open book appointment. Your current property information and the 2023 assessment roll book are available online at: <u>www.accurateassessor.com</u>. After speaking with the assessor, if you still wish to object to the assessment, contact **Clerk- Bruce Jamroz at 715-693-2275** to file a "Form of Objection" and to schedule an appointment before the local Board of Review. A written or oral intent to object with the Clerk must be filed at least <u>48 hours prior</u> to the Board of Review. The Board of Review will meet at the Mosinee City Hall on Tuesday May 23rd from 3:00 pm to 5:00 pm. Appearances at the Board of Review are by prior appointment only. The Board of Review functions like a court and is required to evaluate evidence <u>based on facts</u>. You must provide <u>factual information</u> showing your property is incorrectly assessed.

Storing Refuse and Recycling Carts Between Collection



Residents who have alley refuse and recycling collection should store their carts outside the alley right of way area (generally 5' to 10' from the edge of the alley surface). This right of way area is generally needed for alley maintenance (snow plowing, grading gravel, and utility work). Carts can be set out for collection in alleys after 6:00p.m. the day prior to collection and should be removed within 24 hours after collection.
