

#### CITY ADMINISTRATOR REPORT

The Mayor, City Council and City Staff have been working diligently for the past three months to develop the City's annual budget for the 2023 fiscal (calendar) year. After holding a public hearing on November 28, 2022, the City Common Council unanimously adopted the 2023 City Budget.

The 2023 Budget includes funding for the hiring of an additional patrol officer after July 1, 2023. After field orientation training is completed, the new position would allow the Department to create a new patrol shift that would provide an additional officer during the service call peak hours of 4:30 PM – 2:00 AM. With financial assistance from the Mosinee School District, the 2023 Budget also includes adding another patrol officer position after October 1, 2023 that would eventually allow the Police Department to provide a second School Resource Officer to the Mosinee School District. The 2023 Budget also includes funds (non-tax levy) for site preparation expenses related to the development of a new neighborhood park for the Maple Ridge Road area and funds (non-tax levy) to install a 10'-wide granite multi-use trail from North River Road to Oconto Road.

Although the 2023 Budget does not include funds for a major street construction project, the City is currently preparing engineering plans to repave Main Street (from 4<sup>th</sup> St. to Rangline Rd.) in 2024. The City has been awarded a Surface Transportation Grant from the Wisconsin Department of Transportation that will cover 50% of the Main Street project costs.

We are pleased to report that the City's two Tax Increment Districts are continuing to succeed due to the significant commercial developments that have occurred within the two districts! The equalized value of Tax Increment District No. 2 (generally located in the Business Park area) has increased by +\$21,144,100 (+164%) from \$12,930,700 when the District was created in 2006 to an equalized value of \$34,074,800 as of January 1, 2022! The equalized value of the Downtown Tax Increment District No. 3 has increased by +\$5,531,400 (+67%) from \$8,228,900 when the District was created in 2013 to an equalized value of \$13,760,300 as of January 1, 2022!

# **Secure Your Mailbox**

Reminder to Check Your Mailbox Before Snowplowing Season Please inspect your mailbox and post to insure that it is installed properly. Just a reminder to make sure mail boxes are sturdy and able to withstand the force of plowed snow. Make sure the posts are solid in the ground, and boxes will not pop off if a pile of snow is pushed against it. Rotted wood posts and rusted steel posts will not withstand the weight of snow being pushed against them. Plow Operators are instructed to be cautious near mail boxes. In most cases a properly installed mail box will permit a snow plow to clear snow around it. Most cases of damaged mail boxes are caused by heavy snow hitting the box. The mail boxes are not usually hit by the plow. A mailbox with alleged damage from a direct hit by a City snow plow must be reported immediately and will be visually inspected by City staff. It is the policy of the City to only reimburse the owner for mail boxes broken from coming in direct contact with the plow.

There is no charge to use the ice during our open skate hours.

Hours are dependent upon rink availability and vary monthly. There is no charge to use the ice during open skate hours.
