- Upgrades to electrical & plumbing services
- Garages and sheds
- Interior Remodeling (new walls, bathroom upgrades, kitchen upgrades, finishing basement, etc)
- Siding
- Decks, Patios, Porches
- Fences, Driveways, and Swimming pools
- Moving existing buildings into the City
- Roofs – (No charge for permit – permit required / Metal roof materials not allowed)

Building Permits are not required in the City of Mosinee for the following projects:

- Replacement of Windows, Doors

Dear Mosinee Resident:

I hope this monthly update finds you well and that you are looking forward to the warmer weather that is just around the corner. I would like to pass along several updates from our February Common Council meeting. First, the Common Council approved the preliminary plat for the Stoneridge Subdivision first addition. The preliminary plat adds 16 single-family lots at the east end of Fairway Drive and Stoneridge Drive. This addition is another example of expanding housing opportunities on the City's east side in recent years.

I am also happy to report that at our February meeting, the Council approved a proposed plan to use American Rescue Plan Act dollars allocated to the City to cover several projects that are part of the City's 2022 Budget.

Based on new directions from the Federal Government regarding permissible uses of ARPA funds, the City is able to tackle these projects without borrowing. By using ARPA funds already allocated to the City to accomplish these projects as opposed to borrowing approximately \$400,000, we will lessen the need to increase property taxes in 2023. Projects for which the Common Council approved the use of ARPA funds include the following:

1. Business Park Water Tower Painting Project,
2. Police Department Radio System Replacement Project,
3. Police Department Garage Wall Restoration Project,
4. State Highway 153 Pavement Replacement & Sidewalk Project,
5. Wisconsin Avenue Pavement Replacement Project, and
6. Recreation Center Parking Lot Sealcoating Project.

With spring just around the corner, the Common Council also approved dates for Spring Cleanup. This year, Spring Cleanup will occur between April 20-23, 2022. Spring Cleanup is for Mosinee residents only. For questions on items that are charged for disposal, please contact City Hall at 715-693-2275.

Finally, as weather turns warm, construction season will soon be upon us. I would like to remind residents that the Wisconsin Department of Transportation will be repaving State Highway 153 from the Wisconsin River Bridge to the western boundary of the City this summer. It is anticipated that the project will run from the end of May to the beginning of September. While this will disrupt normal traffic flow during these times, the end result is long overdue.
